1. The Company had provided Remote E-voting facility as per the provisions of Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015 (the Rules) for its members to exercise their right to vote in respect of business to be conducted at the **39<sup>th</sup> Annual General Meeting** held on **30<sup>th</sup> day of September, 2023.**



The Company had availed the E-voting facility offered by the KFin Technologies Pvt Ltd e-voting for conducting remote e-voting by the shareholders of the Company.

The E-voting module was kept open from (09:00 A.M.) on 27<sup>th</sup> day September, 2023 till (05:00 P.M.) on 29<sup>th</sup> day of September, 2023 and the KFin Technologies Pvt Ltd e-voting platform was blocked thereafter.

2.
